CNO Policy on New Housing for development at 2225 East Lake

Hennepin County broke ground in January on phase 1 of redevelopment of 2225 East Lake, the 6.5 acre property immediately south and west of Lake Street and Hiawatha. In addition to new retail, County services, and a public plaza and permanent home for the Midtown Farmers Market, plans call for a total of 565 new homes to be built by one or more developers who would partner with the County. Commissioner Peter McLaughlin asked the CNO Board to present its desired mix of housing for the overall development.

The Corcoran Neighborhood Organization's Land Use & Housing committee led a series of discussions, fact-finding and presenta-

Types, number of bedrooms, and unit size. CNO advocates for a wide mix of housing opportunities reflecting the diversity of today's Corcoran neighborhood in terms of family size and income, cultural background, and transportation habits.

The mix should include as many ground-level walk-out units as possible, along with some live-work / artist units, senior / supportive units, and intergenerational opportunities. In terms of number of bedrooms and unit size, the mix should include 1-bedroom and studio units, & micro / smaller units as one tactic to achieve affordability.

tions, and community debates on these topics over the last 9 months with the final meeting on Jan. 7 attended by a diverse mix of renters, homeowners, longtime and new residents representing a wide range of backgrounds and perspectives. Informed by these discussions, the CNO Board has finalized a 1-page policy to present to Hennepin County.

The board recognizes that development will play out over multiple phases and at least ten years of time, during which numerous economic and market trends will change and affect developer preferences, resources, and constraints. The policy emphasizes goals unlikely to be met by market forces alone.

CNO is especially enthusiastic about achieving more 3- and 2-bedroom units, which currently comprise just 1% and 26% of our existing apartment stock, respectively. This push also responds to a boom in Corcoran's population under 5 years old and in households with children under 18, relative to greater Minneapolis. We also advocate for substantial on-site, outdoor play spaces and amenities to ensure livability for children and families

El Condado de Hennepin rompió el pavimento en enero para la fase 1 de reorganización en 2225 East Lake, la propiedad de 6.5 acres al sur y oeste de Calle Lake y Hiawatha. En adición a nuevos negocios, servicios del condado y una plaza pública y hogar permanente para el Mercado de Granjeros de Midtown, el plan requiere un total de 565 casas nuevas que sean construidas por uno o más urbanizadores quienes se asociarían con el condado. El comisionado Peter McLaughling pidió a la directiva del CNO presentar su mezcla de viviendas deseadas para todo el proyecto.

Black History is American History

February has many holidays and observances. One of these is Black History Month. Founded in 1926 by the historian and educator, Carter G. Woodson, it initially only lasted a week in February. The celebration intentionally coincided with the birthdays of Abraham Lincoln and Frederick Douglass - two Americans who helped shape black history. Woodson's goal was to integrate the teaching of black history into the classrooms of America's schools. The "goal was, first, to give blacks a sense of pride in their accomplishments and, second, to educate whites on the many contributions made by African Americans."

The weeklong observance was expanded to include all of February in 1976 as part of the United States Bicentennial celebration. President Gerald urged Americans to "seize the opportunity to honor too-often neglected accomplishments of black Americans in every area of endeavor throughout our history."

However, there are many people in the African American community that

are skeptical of Black History Month. Articles in The Journal Of Blacks In Higher Education question if Black History Month still serves a useful purpose, "singling out African Americans for special attention in February reinforces white beliefs that black history is not worthy of general recognition." There is also the concern that large corporations "make token efforts to promote an awareness of black history in an effort to further their marketing efforts in the black community."

At my school, I guess we side with the critics of Black History Month as it is currently observed. Black history is American history so it is part of our education year round. Historian, John Hope Franklin (The Journal Of Blacks In Higher Education) even points out that in 1936 Carter G. Woodson said that "he looked forward to the time when it would not be necessary to set aside a week." Woodson "fervently hoped that soon, the history of African Americans would become an integral part of American history and would be observed throughout the year."

Perhaps on this 40th anniversary of the weeklong awareness being stretched to include the whole month we can do our part to neigh Carter G. Woodson's (and many others) idea for equality become a reality.





Building Bridges: A Call for Southside Solidarity with **North Minneapolis**

I moved to Minneapolis (and to Corcoran Neighborhood) just a few months ago. As born and raised Midwesterners my girlfriend and I wanted to stay in this part of the county, but live somewhere progressive and dynamic. We chose Minneapolis for the bike scene, the affordable cost of living and excellent job market; in general, the high quality of life. Within months of moving to Minneapolis I had affordable, stable housing and a salaried job with a fair schedule and paid sick time.

Shortly after moving here, my girlfriend and I participated in the annual "Cirque Du So Gay" Bike Race. It was as a result of this race, where an organization called Neighborhoods Organizing for Change was one of the stops, that I learned Minneapolis may not be the "high standard of living" utopia I thought it was...at least not for everyone. At this first visit to NOC I met incredible, dynamic Northside community organizers who opened my eyes to the fact that Minneapolis has some of the worst racial disparities in the county, and most of the city's residents of color, especially low-wage workers, face a very different reality than I do here. I learned, in the paraphrased words of a NOC organizer, that there are two economies in Minneapolis; one that works for people that look like me, and one that does NOT work for people of color.

Had it not been for this event, I honestly may not have had much reason to get over to North Minneapolis. In fact, I would wager that before the 4th Precinct occupation, Southsiders regularly coming to the Northside numbered pretty low. Through my involvement with NOC campaigns, I learned about the glaring, egregious and long standing racial and economic disparities in a city I had previously thought to be a model of equity. It is because of these realities that I am involved with NOC as a donor / sustaining member and as a volunteer, and why I urge Southsiders like myself to connect with the Northside. There is awesomely strong leadership from the people on the Northside, and as Southsiders we can stand with communities there, in the words of another NOC organizer, "by elevating and amplifying these voices whenever possible". The racial and economic disparities in Minneapolis are not confined to North Minneapolis, and in building stronger bridges we can build an even stronger movement for racial and economic equity in Minneapolis.

Neighborhoods Organizing for Change (NOC) is committed to building Black leadership and advancing racial and economic equity for communities of color. Organizers at NOC are leading a Southsiders Organizing Group, to build NOC membership and support in South Minneapolis. Oppressive, unequal systems of power are only strengthened by our silence and divisions, so let's build bridges together.

Creando Puentes: Un Llamado a la Solidaridad del Sur con el Norte de Minneapolis

Me cambié a Minneapolis (al vecindario Corcoran) unos meses atrás. Como personas nacidas en el medio oeste, mi novia y yo decidimos establecernos en esta parte del país, vivir en algún lugar progresista y con dinamismo. Elegimos Minneapolis por su ciclismo, por el costo médico de la vida y por su excelente fuente de empleo y, en general, por la alta calidad de vida. A meses de llegar a Minneapolis, obtuve vivienda estable y módica, empleo con salario y horario justos, y compensación por enfermedad.

Al poco tiempo de llegar aquí, mi novia y yo participamos en la carrera de bicis "Cirque Du So Gay". Fue como resultado de esta carrera, que una de las paradas fue en la organización conocida como Vecindarios Organizando para el Cambio (NOC en inglés), y donde aprendí que Minneapolis quizás no es la utopía de "alto nivel de vida" que yo creía... al menos no para todos. En esta primera visita a NOC conocí a organizadores comunitarios increíbles y dinámicos, quienes me abrieron los ojos al hecho de que Minneapolis cuenta con una de las peores disparidades del país en cuanto a raza y la mayoría de residentes de color de la ciudad, especialmente los trabajadores de bajos ingresos, que enfrentan una realidad muy diferente a la mía. Aprendí, parafraseando a un organizador de NOC, que hay dos economías en Minneapolis, una para la gente como yo y otra que NO incluye a la gente de color.

Si no hubiese sido por este evento, honestamente no tendría razón suficiente para ir al norte de Minneapolis, de hecho, apostaría a que antes de la ocupación del 4to Precinto, los sureños que regularmente vienen al norte son muy pocos. Por medio de mi participación en campañas de NOC, aprendí sobre la notoria, indignante y vieja desigualdad racial y económica, en una ciudad que previamente, pensé, era un modelo de equidad. Es debido a estas realidades por lo cual participo en NOC como donante / miembro activo y voluntario, y la razón por la cual urjo a la gente del sur, como yo, a conectar con el norte. Hay liderazgo impresionantemente fuerte de la gente del norte y, como sureños, podemos solidarizarnos con las comunidades de allá, en palabras de otro organizador de NOC, "elevando y amplificando estas voces dondequiera que sea posible". Las desigualdades raciales y económicas en Minneapolis no son únicamente en el norte de Minneapolis, y al construir puentes más fuertes, podemos construir un movimiento aun más sólido para lograr igualdad racial y económica.

Vecindarios Organizando para el Cambio está comprometida en construir liderazgo afroamericano y avanzar en cuanto a la igualdad racial y económica en las comunidades de color. Los organizadores de NOC lideran un Grupo Organizativo de Sureños, para incrementar el numero de miembros y apoyo en el sur de Minneapolis. Los sistemas de poder opresivos y desiguales se fortalecen con nuestro silencio y divisiones, así que construyamos puentes juntos.



BOARD OF DIRECTORS MEETING

Lisa called the meeting to order and asked Miguel Goebel to lead us in the Farmer's Market discussions.

Midtown Farmers Market committee

A. Appoint Mike Novak to CNO Board as committee co-chair

Mike Novak has worked with the market communication team, did the banners (professional graphic designer), lives in the neighborhood and is interested in getting more involved with the Farmer's Market and CNO Board.

Mike would be the CNO Liaison on the Board, the second cochair is still open and staff is currently recruiting. The second co-chair will chair the Market meetings.

A motion was made, seconded and carried that Mike Novak be assigned to the CNO Board as the Market Committee Co-Chair.

B. Approve MFM policy changes *

Miguel explained that the Market budget continues to grow. Indoor restrooms and the increase in cost is an issue. The restrooms are a health issue as well as an amenity. The first place to look to cover the increase in Market expenses was Vendor fees, as they have not been reviewed in some time. Miguel has looked at rates at other farmer's markets in the area and the proposed fees are in line with other markets. He clarified the \$5 daily increase and discussed annual fees. There is a discounted stall fee for those that pay the season in advance. This would increase the Market budget income for vendor fees from \$41,400 in 2015 to \$50,700 in 2016. Motion made, seconded and carried to approve the new fee schedule.

Miguel explained the new Personal Safety Emergency Policy came about due to an employee having a medical issue at the Market. At the time, the vendors didn't know exactly how to handle it. So an Emergency Policy for Vendors' benefit should be in writing. Phillip suggested that property damage be added to second paragraph. Clarification that "Staff" should be changed to "Market Manager". Motion made, seconded, carried that the Policy be accepted with the indicated changes.

Treasurer's Report and Budget Presentation (April)

C. Approve 2016 budget

This was discussed at length at the last meeting. Included in this new narrative in Other Personnel is the cost of offering medical benefits to new personnel. Also discussed was the Center for Energy and Environment's estimated cost of LED lighting for the CNO building which would lessen the cost of electricity and last much longer. The numbers are listed under Capital Improvements. Installed Cost is the cost it would normally be through a regular vendor. Then the rebates, grants are considered showing the final cost and yearly savings. Eric stated that foundation grants could also cover the items that we need for the Market and Capital improvements that we need to improve services for the community. Phillip noted that the Budget and the Narrative are proposed and amendments will come throughout the year as adjustments are made. Lisa thanked everyone involved for the thorough



evaluation that was done, which has not been done in the past, and how it helps the Board to focus on those items that we need to address. Motion made, seconded and carried to adopt the Budget and Narrative.

D. Update on fall fundraising campaign Staff is pleased with the turnout on "Give to the Max" and are doing follow up calls on those that have lapsed. However, it was felt by those in attendance that it should have been so much better. The Board will continue outreach throughout the year, instead of only the Year-End concentration.

Economic Development committee update (Matt)

- E. Retail strategy for 2225 East Lake development Several things are being worked on at this time. One item that continues is the Retail strategy for the new County building lower lever on Lake St. The Committee met with the county and discussed the community needs for that space. Community interest were in an early morning and lunch afternoon coffee/lunch for people on way to railway station or county employees and/or a nighttime restaurant looking out over the plaza. They could share a kitchen. One space is 3,000 sq. feet and another is 4,000 sq. feet. Other interests were a bank, or convenience store. Now NDC is opening up a process to identify businesses that may be interested in the space. It needs to be a business that is prepared to pay the going rate for the space. The committee has spoken to an established café who is showing an interest in a second location. If there is any business that is interested in the location, there are many opportunities available and the CNO can facilitate.
- F. Training for Micro-Entrepreneurs in Jan. is set to begin and there already has been interest shown by several local business.

Land Use & Housing committee (Phillip)

G. MOTION: CNO advocates that Minneapolis Public Schools allow access to its building at 2019 East Lake by the Preservation Alliance of Minnesota for the purpose of surveying for historic value prior to the building's demolition.

This is related to the property that is the Paco building that was originally the Burma Shave building (S/W corner of Lake St. and 21st Ave So.) and if there was an interest in saving the legacy of the building in some form.

Phillip questioned who would be the person checking the historical content of the building. Shari Albers from Powderhorn spoke on the issue. Steve Sandberg pulled together history-minded community members and started this effort. The bldg. was built in 1900 and in 1925 Burma Shave moved in there. It became a national company and their signs were erected around the country. This community committee

would like to see access to the building and requests that CNO send a letter to the school district permitting them access. The Preservation Alliance of Minnesota would conduct the survey. Phillip explained that the point would be to verify the condition and complete a report that could be filed with Hennepin County so that this could all go on record. The motion was modified to request that the Minneapolis School District allow the Preservation Alliance of Minnesota access to the building in question. Motion made, seconded and carried by the board.

- H. The Hi-Lake infrastructure study that will be conducted by City and funded by the City and County was discussed. Our Committee will be meeting with Councilmember Alondra Cano, Lisa, Eric and Phillip to discuss the future study and make recommendations. Evaluation of the territory and suggestions for the improvements will be made in a formal report that will then be submitted to the elected officials who need to make the capital dollars available. City, County, MNDOT, and Metro Transit would need to be involved. Our goal is to get a plan.
- South High campus planning advocacy with South, CM Cano

CNO met with South High Foundation and Councilmember Alondra Cano. There is general concern about the property that they now have on Lake St. They have a budget for improvements for So High and the new Adult basic Education building. Everything is happening without any community involvement or knowledge of the future plan. A letter will be drafted to be signed by Councilmember Cano, the school principal and CNO to encourage the Minneapolis School Board to commence a master plan exercise, which includes all the concerned parties in community, to commence in a timely manner. Phillip will complete the draft letter and send to Lisa for signature and share the letter with the Board.

J. Housing Policy Plan update No update at this time but will continue to work on it in the

The report covered background surveys and the next steps moving forward; e.g. government structure, costing out the space improvements and then shopping around to find the funding. There is a meeting on Monday morning to continue the discussion on the park.


